

## Trade Fair Visa

If Germany or Austria is your main destination in order to attend a trade fair as an exhibitor or a visitor with your stay not exceeding 90 days <u>and</u> you are in possession of an invitation letter by the organising trade fair, which states you as an exhibitor or visitor, you will need to apply for a trade fair visa.

Based on the submitted documents, the Consulate General will need to verify your purpose of stay, sufficient funds and a motivation to return to Canada.

The visa application may be submitted at the **earliest 6 months prior** to the planned trip and should be submitted **no later than 15 days prior** to departure. The visa section endeavors to process applications as timely as possible. As a general guideline, processing of an application for a visitor visa with full set of required documents may take up to 15 days. In justified cases where further investigation is necessary or information needs to be sourced, processing time may be extended to up to 45 days. **No expedited processing time will be guaranteed for late applications**.

The list below shall assist you in having **all** of the following documentation **prepared** in the **given order** before you come to your visa appointment. **Incomplete documentation may result in the rejection of your application.** 

You have to submit your application **in person**. Please note that fingerprints will still have to be taken from all applicants.

All documents need to be presented in the **given order in original**. Should you wish to keep any originals, kindly provide an additional copy.

Please prepare your documents in the order indicated below and **submit with a print-out of the list:**

	Valid and signed <b>passport</b> (issued within the <b>last 10 years</b> and valid for <b>at least 3</b> months after leaving the Schengen area with at least <b>2 empty pages</b> )
	Application form fully completed, duly signed
	Declaration "Use of mail services", , and Information pursuant to sec. 54 (2) 8, 53 of the Residence Act, duly signed
	<b>Biometrical Passport size picture, stamped</b> , not older than three (3) months with a bright background and frontal view of the face (please do not attach the picture to the application form). <b>Digitally-altered passport pictures will not be accepted.</b>
	Copy of your valid passport's data page

Valid <b>permanent resident card</b> or <b>Canadian temporary resident visa</b> , valid for <b>at least 3 months</b> after leaving the Schengen area ( <u>no exception can be made</u> !)
<ul> <li>Letter from your employer (not older than 4 weeks) stating the reason for your trip, your position within the company, the length of employment and the coverage of your travel costs, if applicable, OR</li> <li>Enrolment letter from your university stating the reason for your trip and the coverage of your travel costs if applicable OR</li> <li>if self-employed: business registration, OR</li> <li>recommendation of the local Chamber of Foreign Trade, OR</li> <li>another proof of your specific interest in attending the trade fair</li> </ul>
For exhibitors: exhibitor pass ("Messeausweis") stating dates of the fair, full ad- dress and name of the company you are representing For visitors: visitor pass/ticket stating dates of the fair
Flight reservation/itinerary (including your name) to Germany/ Austria and back to Canada or final destination
<ul> <li>Proof of sufficient funds to cover the costs of your intended trip:</li> <li>- last three (3) months bank statements with your name ( if your company does not cover the cost of the trip)</li> <li>- if self-employed: last three (3) months bank statements of the business accounts</li> </ul>
<b>Proof of travel health insurance</b> (Canadian or German), <b>valid for the entire</b> stay in the <b>Schengen Area</b> with a minimum coverage of 30.000 € (approx. 50,000 CAD), including the following details: name of insured person, length of <b>coverage</b> , insurance sum and repatriation coverage. In case you want to take several trips within the period you are applying for, health coverage for the first trip is sufficient. Please note that health insurance coverage by <b>credit card</b> is not valid unless you present a letter from the credit card company with details of coverage of your trip.
<b>Prepaid self-addressed Xpresspost envelope</b> (Canada Post only), <b>Regional</b> Standard to Ontario or <b>National</b> Standard to all other provinces (shipment to a Canadian address only)
Visa fee; for further information please check on our website Note:Exhibitors are exempt from charges, if exhibitor pass ("Messeausweis") is presented

**Please note** that the German Consulate reserves the right to ask for additional documents at any time during processing. Submission of the above mentioned documents <u>does not</u> <u>guarantee</u> that a visa will be granted.
